- 3. Results from our survey sent out in January: Rhonda will read over the questions and provide the results from the family's feedback.
- 4. Flyers are completed, and Rhonda asks all board members to hang a few within the community.
- 5. Rhonda gave Hoover, Harris, and Co. a 30-day notice that we are discontinuing our accounting services with them. We will be going with Jennifer Grim from Integrity Books and Payroll. Shae gave Rhonda this lead. Everything sounds excellent, and Rhonda will meet with Jennifer sometime soon. The only setback is that Rhonda has to find someone to do the IRS taxes at the end of the fiscal year. Integrity only does payroll.
- 6. The Butter Braid spring fundraiser is scheduled for March 31 through April 11, 2025.
- 7. Rhonda and the teachers attended the Rocky Mountain Early Childhood Conference last week. The team shared many new and exciting ideas, and I want to implement some of them this next school year.
